ADDICTION: ALCOHOL, DRUGS, GAMBLING

As provided by the State-Regions Agreement dated 07/07/2016, the courses valid for all security subjects can be used through e-learning delivery procedures.

Training Goal: Analyse the primary effects of addiction not only in the workplace, but also in daily life.

Certificate of Attendance: Each participant will receive a certificate, after having taken and passed a test, in accordance with the State-Regions Agreement 21 December 2011, valid over the entire national territory. The documentation will be transmitted, over computerised form, personally to each user who will be able to download both the Attendance Certificate and the Citizen's Training Booklet directly from the platform.

Total Duration of Course: 1 hour

Planned Training: The minimum duration of the refresher modules varies according to the subjects to be trained (Annex II State-Regions Agreement 07/07/2016).

TECHNICAL REQUIREMENTS FOR USING THE PLATFORM

Registration Method: User registration on the platform

Skills and Requirements: The participants must be able to access the technologies used, have familiarity with the device chosen in order to take the course (Computer or Tablet) and good knowledge of the language used.

Communication interface: Platform communication is made possible through direct contact with the tutor who can be contacted by email at tutor@aifos.it and with technical support who can be contacted by email at assistenza@aifos.it.

Method for Tracking Activities: Every AiFOS course is created in accordance with the international SCORM 1.2 standard. The use of this form allows AiFOS to guarantee tracking, on its own platform, of all the information regarding the participants and the use of the didactic materials.

Tracking of the platform information, user access and certification is stored by AiFOS, in accordance with the terms prescribed by law.

The platform is equipped with the LMS management system, able to monitor and certify:

- The progress and completion of the learning activities for each user
- The tracking of each activity carried out while connected to the system and its duration
- The tracking of the individual learning units structured in Learning Object, containing a series of tools, such as the
 text of the lesson, the audio explaining the topics, learning support documents, brief examples, and animation
 videos.
- The procedure for and passing of the learning evaluations.

Time Frame for Course Availability: The duration of the course is expressed in hours.

The time period available for completing the entire course, from the moment of purchase, is indicated within the platform.

Method of Learning Assessment: Learning verification is carried out through participation in intermediate testing useful for self-learning, provided for each learning unit and a final test for the purpose of consolidating the knowledge acquired during the entire course.

Each final test is made up of 10 **questions w**ith multiple choice answers (each made up of at least three alternative answers) based on the type of course. The final result is considered positive if at least 70% of the questions are answered correctly.

AIFOS NATIONAL TRAINING BODY: AiFOS, the Italian Association of Instructors and Operators of Work Safety, operating over the entire country, by decree (art. 32, paragraph 4 of Legislative Decree 9 April 2008, n. 81 and the State-Regions Agreement of 7 July 2016) for the realisation of training courses issuing certification.
